## Fire Protection Permit Fees

**Project Valuation** to be used in computing permit fee is the fair market value of work, including the total costs of materials, labor, profit and overhead for which the permit is issued.

Minimum Permit Fee <i>(All Permit Types)</i>	\$100.00
Fire Suppression System	1.25% of Project Valuation
Fire Alarm System	1.25% of Project Valuation
Commercial Fuel Storage Tank	1.25% of Project Valuation
Other Fire Protection System	1.25% of Project Valuation
Plan Review Fee <i>(Charged For All Permit Types When Plans Must Be Submitted)</i>	65% of Permit Fee
Minnesota State Surcharge must be charged in addition to permit fees for all permit types:	.0005 x Project Valuation
